

In partial modification to IMPA Order No. 469/J of 2016 dated: 28.11.2016 with regard to rate of refreshment of sponsored/non-sponsored training courses, it is hereby ordered that:-

- 1) The rate of refreshment in respect of both sponsored and non-sponsored training courses shall henceforth be Rs. 150/- (uniform) per head/per day.
- 2) For Residential training courses the rate of Breakfast shall be Rs. 50/- and Rs. 100/- for Dinner per trainee per day (for both sponsored as well as non-sponsored).
- 3) The rate for Course dinner (special) as and when authorities so desire to host such a Dinner shall be Rs. 250/- per head.
