There is no adopted ratio in the recruitment rules of J&K IMPARD in respect of the fellows. All the candidates who fulfil the requisite eligibility criteria have been declared eligible to be called for interview by the Screening Committee constituted for the purpose	
05.	How many of the applicants have fulfilled the eligibility criteria? Please give details in reference to Notice No. 01 of 2014 dated 02.05.2014. How many applicants have fulfilled/rectified deficient documents by 10 June, 2014. Pl. Give details.	Out of 127 candidates, who fulfilled the eligibility criteria as laid down in the advertisement Notice No. 01 of 2013 dt. 14-10-2013, 25 candidates were found conditionally eligible subject to the production of some deficient documents. Vide Notice No: 01 of 2014 dated 02-05-2014, these conditionally eligible candidates were asked to submit their deficient documents by 10-06-2014. Out of 25 candidates, 19 have submitted the deficient documents, again out of which in case of 08 the veracity of documentary evidence shall be verified at the time of interview.	
06.	What is the reason of delay in conducting interview for the positions. Since it is advertised more than a year ago, what is the validity of advertisement? Shall it be re-advertised, If not, what stand is being taken by J&K IMPARD, if the eligibility/experience of selected/rejected aspirants is upgraded?.	Due to the poor response in some disciplines of the advertised posts, the same have been re-advertised vide Advertisement Notice No: 01 of 2014 dated 15-07-2014 and Notice No: 02 of 2014 dated 15-07-2014, the last date for receipt of applications was fixed as 5 th August, 2014. Subsequently, the Institute initiated the process of screening the application forms but due to major floods in the J&K State and then imposition of Model Code of Conduct due to Assembly Elections, the process could not be completed. After Assembly elections the process has been further resumed. Interviews for the eligible candidates shall be held shortly. In case suitable candidates are not found in any discipline the vacant posts shall be re-advertised. The candidates who were earlier found ineligible for the want of requisite qualification and have now upgraded	

		their qualification can definitely apply again when the vacant posts are re-advertised.
