Whereas, this Institute received a letter with No: GS-1(4R) 19/5183 dated: 24th July, 2019 from Lt. Governor's Grievance Cell Secretariat J&K alongwith a complaint moved by Ms. Basanti Pandita, Daughter-in-Law of Late Shri Maheshwar Nath, R/o Pargochi Shopian, presently addressed as A/P C-7, DDA Flats, Sector-7, Dwarka, New Delhi wherein she has complained that the actual name of Shri Ashok Kumar Bhat, retired Section Officer, J&K IMPARD, Jammu is Shri Shakti Bhandhu and Shri Ashok Kumar Bhat who died in 1978 is his real younger brother.

Whereas, this Institute was directed by the office of Lt. Governor's Grievance Cell Secretariat J&K to look into the allegations levelled against Ashok Kumar Bhat By the above mentioned lady. An Enquiry Committee was constituted to look into the allegation levelled in the complaint. Three committee members visited Village Achan District Pulwama for on spot verification and inter-acted with the local people in the vicinity and other appropriate persons viz lumberdar and Chowkidar of the Village. The Committee after enquiring thoroughly concluded that the actual name of so called Shri Ashok Kumar Bhat, retired Section Officer, J&K IMPARD, Jammu is Shri Shakti Bandhu and not Shri Ashok Kumar Bhat. They further added that Shri Ashok Kumar Bhat who died in the year 1977 was the real younger brother of Shri Shakti Bandhu.

Whereas this Institute also requested the Deputy Commissioner, Pulwama to furnish the family details of Shri Jai Lal Bhat of Achan, Puwama, father of so called Shri Ashok Kumar Bha. The Additional DC Pulwama vide his letter No: DCP/ADC/PA/19/567

dated: 06.12.2019 based on the report of concerned Patwari has confirmed that late Shri Ashok Kumar Bhat, son of Shri Jai Lal Bhat R/o Achan, Pulwama has died many years ago.

Whereas the case has been referred to Sr. Superintendent, Crime Branch, Srinagar for further investigation.

Therefore, on the basis of above facts the payment of pension to Shri Ashok Kumar Bhat Retd. Section Officer, J&K IMPARD Jammu is hereby withheld till further orders.

Respected Sir,

I want to inform you that one Ashok Kumar S/O Late Sh. Jai Lal R/O, Acchan Pulwama is a Cheater/Fraud Man, who had cheated Govt. of J&K. By providing Certificate of his dead younger brother to get Job in institution of Management & Public Administration (IMPA Deptt.) for himself. The man who was working in IMPA Deptt. From last 30 years (Approx.) in the name of Ashok Kumar Bhat is actually Mr. Kakaji as nika name in Home/Village and SHAKTI BANDHO on school records and certificate in then High School Acchan Pulwama. He is not ever 9th Pass.

In 1978 his younger brother Ashok Kumar died due to accident when he (Ashok Kumar) was residing in BA 2nd years in Co-education college Annantnaga Kashmir.

After some years Kakaji (Shakti Bandho) got link with some person and got Govt. Job in institute of Management & Public Administration (IMPA Deptt.). By providing certificate of his dead younger brother Mr. Ashok Kumar.

Till date of Appointment & now after Retirement no body complaint against him. Ashok Kumar had Cheated Govt of J&K. Please arrest him and investigate against his actual name and qualification. Also direct the AG'S Deptt to stop his pension till further investigation and cease his accounts & property also.

If no action will be taken against him, Next will be media to investigate in this matter. Regarding any query or information I am ready to help Govt. of J&K and other concerned Deptt. Hope you will take quick action against this culprit.

In reference to letter No. GS-1(4R) 19/5183 dated: 24-07-2019 received by this Institute from Governor's Secretariat J&K. Complaints-Public Grievances Cell regarding the complaint submitted by Ms. Basanti Pandita, Daughter-in-Law of Lt. Sh. Maheshwar Nath R/o Pargochi Shopian, A/P C-7, DDA Flats Sector -7, Dwarka, New Delhi against one of the employee of this Institute namely Sh. Ashok Kumar Bhat, Retd. Section Officer. In this context the Institute constituted an enquiry committee of the following Officers/Officials vide IMPA Order No. 418 / J of 2019 dated: 27.11.2019 to enquire into the allegations levelled by the said applicant (copy enclosed as Annexure "A").

The three Officers of the above constituted Committee personally visited Village Achan District Pulwama for on spot verification and interaction with the local people and other appropriate persons viz Lumberdar and Chowkidar concerned. The Officers after having conversations/interactions with the locals in the vicinity submitted their enquiry report wherein they have stated that the actual name of so called Shri Ashok Kumar Bhat retired Section Officer, IMPARD, Jammu is Shri Shakti Bandhu and not Shri Ashok Kumar Bhat as Shri Ashok Kumar Bhat, who died in an accident, was the real younger brother of Sh. Shakti Bhandu (copy of the report enclosed as Annexure "B"). This statement was then confirmed from Death Register Records maintained by Chowkidar of the Village that Shri Ashok Kumar Bhat alias Bobji had died on 8th June 1977 (copy enclosed as Annexure "C"). The Officers further added in the report that on the basis of interaction with the local residents of the concerned village including Head of the Village (Lumberdar) that Late Shri Jai Lal had three Sons and two daughters the details of which are as under:-

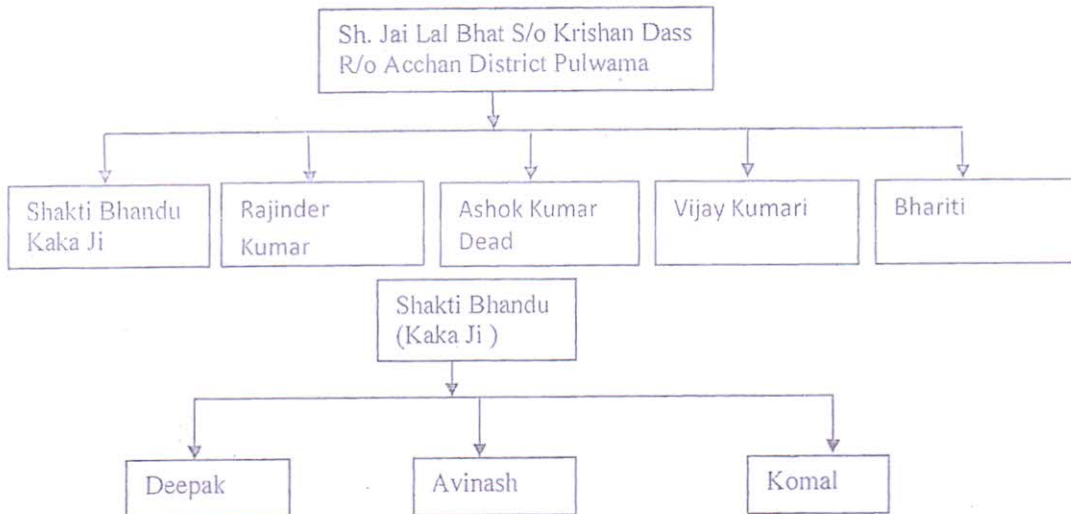
- o Son Shri Shakti Bandhu, Kaka Ji (Nick name)
- o Son Rajinder Kumar
- o Son Ashok Kumar Bhat, Bob Ji (Nick name)
- o Daughter - Vijay Kumari
- o Daughter - Barti

Besides above, the Additional Deputy Commission, District, Pulwama vide letter No. IMPA/RC /Estt/36/99/II/4151-54 dated:02-12-2019 was requested to provide the following particulars of Shri Ashok Kumar Bhat R/O Acchan, Pulwama:-

- a) Details of family of Sh. Jai Lal Bhat.
- b) Details of Ashok Kumar Bhat's siblings.
- c) Details of birth of the children of Sh. Jai Lal Bhat in the Chowkidari birth and death register.
- d) Details of Mr. Kaka Ji- alias by which Ashok Kumar is known in the village.
- e) Any other relevant information.

The Additional Deputy Commission, District Pulwama, Vide their letter No. No.DCP/ADC/PA/19/567 dated: 06-12-2019 reported that Mr. Ashok Kumar Bhat was the third son of Shri Jai Lal Bhat R/O Achan District Pulwama who is no more. (Copy enclosed as Annexure "D"). As per the report of concerned Patwari of Village Achan District Pulwama appended with above said letter from Additional Deputy Commissioner, Pulwama, the family details of Sh. Jai Lal Bhat are reproduced as under:-



The extract of the enquiry report and as per the Revenue records it reveals that the real name of so called Shri Ashok Kumar Bhat, retired Section Officer, J&K IMPARD, Jammu S/O Jai Lal Bhat R/O Achan, District Pulwama is Shri Shakti Bhandu S/O Jai Lal Bhat R/O Achan, District Pulwama as Ashok Kumar Bhat S/O Jai Lal Bhat R/O Achan Pulwama died on 8th June 1977 in an accident. Hence the complaint made by Ms. Basanti Pandita is true and based on facts.
