TERMS AND CONDITIONS

- 2. Only one rate against one item of standard quality should be quoted.
- The tenderer should carefully study the tender document and prepare his 3. offer with all provisions of the document. He should fully acquaint himself with the tender requirements, site location and conditions and all other factors which may directly or indirectly influence the preparation of his tender.
- 4. The successful tenderer shall be responsible for execution of the contract in full and shall not in any case assign or sublet the approved terms or part thereof to any other party.
